All actions were closed with the exception of that in relation to the ICB meetings which is carried over until the next meeting

5. Practice Update;

A discussion was held regarding the wording of the Anima system when patients were trying to make an appointment. TR produced screen shots to highlight what patients were seeing and suggested



when the triage system was closed it would be preferable if the information was on the first screen seen. LR explained this was Anima wording and was used nationally so could not be changed at a practice level.

Changes in NHS regulations now require the system to be operational all day, currently there is a maximum number of patients who can be safely triaged and for that reason the system does close to new requests. How this will be resolved is unclear at the moment.

Phones have been busier since Anima was introduced AC raised an issue regarding the system timing out and MR asked about how quickly patients would receive appointments, LR explained this is difficult to give a definite answer to as there are so many variables. Patients can still see the GP of their choice however for those GPs who only work part time appointments can fill up very quickly.

LR has changed her role in the practice and s now Facilities
Administrator, she will continue to support the PPG. The boilers
have now been replaced and Ambrose Ave has now reopened to
patients, it is still not at full capacity but should be in the next
couple of weeks as appointments work through.

LR updated the group on staff changes.

The new look website went live on Friday but has received some positive feedback.

LR has been told Tiptree has a regular session to offer IT support to its patients. LR will contact Tiptree to see if this can be replicated for Ambrose Avenue
